

# COVID Update for Students

Dear students,

Since the Covid-19 pandemic is still with us and the extraordinary health measures and provisions continue to regulate our daily life, the Vakalo Art & Design College has codified its Covid-19 policy in a five-stage plan, according to the degree of health alert as specified by the Greek government. In every stage, the College implements the measures that are decided by the government and the public health authorities, in the specific conditions of the delivery of its programmes and as required by the subject areas they cover. The five-stage plan gives a general overview of the procedures; detailed information and guidance will be given to you, both orally and in writing, at each different stage, according to the progress of the pandemic.

## Update September 2021

Our approach to Covid-19 is to follow the Greek government guidance and regulations, and to keep all our people safe. We are adapting to the changing world and are making sure that your learning doesn't have to be put on hold. This may mean that teaching could be online or in person, however we will ensure you have access to the highest quality teaching and the best possible student experience.

The following table lays out the Stages of Operations we will move through as the current pandemic roadmap progresses and further announcements are made about the impact of the pandemic on higher education.

Our Stages of Operations illustrate the stages for programme delivery and how things may change in the future (depending on the Greek government requirements). Following the most recent announcement (24/8/2021) we are at **Stage 1**.
